Protecting your privacy is very important to YogaBlaze. We will not sell, lease or exchange your personal data to third parties without first obtaining your express consent.

ABOUT YOGABLAZE NETWORK. YogaBlaze is an online social networking community that connects people through their personal networks and allows them to meet others, find classes & event, buy and sell goods, and perform other transactions. Members create their own profiles, and those profiles are then available to be seen by the public and shown to their Network of friends. A user's personal Network includes the extended group of people that a user is connected to through their friends.

INFORMATION WE COLLECT. YogaBlaze collects information our users submit to us such as their name and e-mail address to allow us to identify users and notify them of changes or updates to our service. We also collect personal information submitted by our users in filling out their profile on the service such as gender, state of residence, occupation, interests, etc. We collect this personal information when our users: (a) sign up as a member (create a profile); (b) make changes to their member profile information; and (c) send e-mail messages, forms, or other information to us via YogaBlaze. Members may choose to provide additional information beyond their basic profile for their personal and professional profiles. Providing additional information beyond what is required at registration is entirely optional, but enables our users to better identify each other and more effectively connect and interact with their network. YogaBlaze may also collect information from users that is unique, but cannot be linked to a specific individual, such as IP Address and browser type. A user's session will be tracked, but each user will remain anonymous. We gather this information on all visitors to YogaBlaze for systems administration purposes and to track user trends, such as our most popular features. We do not link IP Addresses to any personally identifiable information.

THE NING SITE. Like many other Web sites, YogaBlaze Network uses a standard technology from Ning, Inc – www.ning.com. This site provides the underlying technology which supports our social site. YogaBlaze has no associations with Ning besides using its technology therefore any updates to the Ning software may be limited or change without YogaBlaze being able to do anything about the change.

The Ning technology may use “cookies”. “Cookies” are small pieces of information stored on your hard drive -- not on the Ning site. They can help make the Internet experience quicker and more convenient. Cookies allow our users to login without entering their ID and password each time they use YogaBlaze. Cookies help us understand how members use YogaBlaze, which allows us to improve upon the service. Members who disable cookies will not be able to use YogaBlaze.

HOW WE USE YOUR PERSONAL INFORMATION. YogaBlaze Network uses personal information to create a secure and personalized service for our members. The Basic Profile information (name, photo, gender, location) is displayed to all members of YogaBlaze as you choose. All other profile information members provide is private and only available to the YogaBlaze administrators. Email address of YogaBlaze members are never displayed to other users on the system. Users within a Personal Network communicate on YogaBlaze with each other through the YogaBlaze service without disclosing their email addresses. Members may opt out of receiving e-mail from us at any time by following the instructions below in sections 12 and 13.

CLICK TRACKING. YogaBlaze may use a method called "click tracking" to log user movement throughout our service. As part of this effort, we passively collect IP address, Web browser type, [domain names](#), access times, referring URLs and page views for each session. This information may be used to keep track of login names and passwords, to offer users a personalized experience, to enhance navigation, to provide content tailored to the user's interest, and to time out their session.

DISCLOSURE OF PERSONAL INFORMATION. We will not sell, lease or exchange your personal data to third parties without first obtaining your express consent, unless required by law or to protect your membership.

INVITING FRIENDS. If you use our Invite feature to invite a friend to our service, we will ask you for your friend's email address. We'll automatically send the friend an email inviting them to join your Personal Network. YogaBlaze does not sell these email addresses or use them to transmit any communication other than the invitation and reminders to join your personal Network. YogaBlaze stores this information for the sole purpose of sending this invitation and reminders, and for tracking the success of our Invite functionality. The friend receiving the invitation may contact YogaBlaze Network at info@YogaBlaze.com to request the removal of this information from our database.

LINKS TO OTHER WEBSITES. The YogaBlaze site may contain links to other Web sites. Please be aware that YogaBlaze is not responsible for the privacy practices of other sites our users choose to visit. If our users provide any information directly to parties other than YogaBlaze Network (even if those sites are showing the YogaBlaze brand), different rules may apply to the use or disclosure of the personal information disclosed. We encourage you to investigate and ask questions before disclosing your personal information to third parties.

THIRD PARTY ADVERTISERS. YogaBlaze may choose to deploy advertising on the service that is delivered to users through a third party's advertising server. Information about users' visits to YogaBlaze, such as number of times they have viewed an ad (but no personally identifiable information), would be used to serve ads to users on this site.

CHAT ROOMS, MESSAGE BOARDS, AND PUBLIC FORUMS. Please be aware that whenever members voluntarily disclose personal information online - e.g., message boards, chat areas, file uploads, events, and listings - that information becomes public and can be collected and used by

others. By posting personal information online in public forums, members may receive unsolicited messages from other parties.

PRIVACY PROTECTION FOR CHILDREN. In compliance with the Children's Online Privacy Protection Act (COPPA), we will not knowingly provide access to YogaBlaze to persons under the age of thirteen (13). If YogaBlaze later learns that any member is under the age of thirteen (13), we will take appropriate steps to remove the member's information from the database and we will restrict this individual from future access to the YogaBlaze service.

UPDATING AND DELETING PERSONAL INFORMATION. Members can access, change and update their registration and personal information by logging onto YogaBlaze and selecting the Edit Profile option. Users who leave the service may choose to have their personal information deleted by contacting info@YogaBlaze.com and sending their unsubscribe request from the e-mail account used to create their YogaBlaze membership. Unsubscribe requests will generally be responded to within 24 hours, and will generally be acted upon within 48 - 72 hours.

OPT-OUT OF EMAIL. Users of YogaBlaze may choose not to receive email notifications at their registered email addresses. To opt out of these announcements, click the Account link at the top of any page, and uncheck the box next to "Send email notifications."

OPT-OUT OF NEWSLETTER. YogaBlaze has a regular monthly newsletter and other member-related newsletter. To opt-out of receiving these newsletters select "unsubscribe" or "Update Profile" on any newsletter.

SECURITY PROCEDURES. YogaBlaze uses the Ning.com network which has implemented security measures to protect member information from loss, misuse and alteration. Ning.com For more about security on Ning.com see their terms & policies. Every YogaBlaze employee is aware of our security policies, and your information is only available to those employees who need it to perform their jobs.

CONSENT. This Privacy Policy is a part of the YogaBlaze Terms policy. By using YogaBlaze, including services available at the YogaBlaze domains, users are using a service provided by YogaBlaze and they agree to be bound by the Terms of Use and this Privacy Policy. Some terms may be defined in the Terms of Use.

NOTIFICATION OF CHANGES. If YogaBlaze changes its policy and seeks to use your personally identifiable information in a manner different from that stated at the time of collection, you will be notified via email or a system message visible on your YogaBlaze Home page. In addition, if we make any material changes in our privacy practices that do not affect user information already stored in our database, we will post a notice on our Web site notifying users of the change.
